Please find the enclosed outline for the PNC Green Certification Program.

We are working to promote Palms as a leader in sustainability, and we are reaching out to the restaurants in Palms to be part of this important effort. Using best practices from other communities, we've put together criteria for a green certification program that will prove cost effective, achievable, and most importantly, the responsible thing to do for better urban sustainability.

Participating restaurants will be promoted throughout the community and will receive the logo below for display:

Palms Neighborhood Council Green Certification Program for Restaurants

Participation: Restaurant and Food Service operations within the borders of Palms are eligible to participate in this program.

Certification: Participants are verified via inspection by a member of the Palms Green Committee. Once certified, businesses completing the program will be a Palms Green Committee Certified Establishment, entitling the participant to:

- 1. Possess and Display the PNC Green Committee Decal.
- 2. Possess and Display a similar electronic version of this logo for online promotion and use in printed advertising.
- 3. Be listed in a promotional section of the PNC website and featured in promotional and educational materials regarding the program.
- 4. Be a preferred vendor for PNC meetings.

Certification is for two years. There is no fee to participate in this program!

Application: In order to obtain a PNC Green Committee Certification, a business must do all of the following:

• Stock and use only compostable, recyclable, and/or reusable packaging, utensils, and itchenware for on-site, take-out, and delivery services. Participants must not use polystyrene (#6 lastic), whether foam or clear.	
• Participants may not use point-of-sale single-use plastic bags for on-site, take-out, or delivery ervices.	
• Recycle all glass, plastic, aluminum, steel, newspapers, junk mail, and non-food-contaminated aper (cardboard boxes broken down/flattened).	
 Pledge to purchase products with the highest amount of recycled content reasonably available. 	
• Post the PNC Green Committee Certification Decal in a location highly visible to patrons.	
n order to obtain a PNC Green Committee Certification, a business must also either maintain ertification in the Los Angeles Certified Green Business Program, OR do at least 1/3 of the following ptions, as applicable to your business:	g
• Participate in the City of Los Angeles Food/Organic Waste Recycling Program.	
• Eliminate disposable dishes and utensils for dine-in customers. Stock reusable kitchenware.	
• Eliminate individual plastic bottles of water.	
• Offer incentives to customers who bring in their own coffee mugs, to-go dishes, reusable everage containers, or reusable bags.	
• Recycle all fryer oil for donation to a biodiesel program.	
 Provide receptacles for collecting electronic and hazardous waste items that are prohibited from the normal waste stream (batteries, CFL bulbs, e-waste, paint, etc.) and devise a schedule for periodic transfer to a hazardous waste collection center. 	
• Replace all lighting with high efficiency LED bulbs or fixtures.	
• Eliminate single-use plastic straws for all beverages.	
• Install a solar water heater or preheater.	
• Install a solar electric system.	
 Clean all outdoor areas with a broom and damp mop instead of a hose. 	
• Install water-free urinals.	
• Utilize California native plants and/or trees to replace non-native landscaping, if applicable.	
• Stock at least one non-toxic, biodegradable, Green-Seal certified cleaner. Educate staff of your co-friendly preference to use these cleaners as a first choice in all applicable situations.	
• Eliminate the purchase of endangered seafood and purchase seafood from sustainable sources s defined by the Monterey Bay Aquarium's most current Seafood Watch Guide, eliminating service o II seafood from the "Avoid" column.	
Provide a secure location for staff to store bicycles, or install a hike rack in or near facility.



End to end, straws used **DAILY** in the United States could circle the planet more than two-and-a-half times.
