#### Call Summary for 10 Freeway Underpass at Palms Avenue Mural

The Palms Neighborhood Council is looking for artists or artist teams to submit proposals for a new public art mural to be installed at the Palms Avenue underpass with the 10 Freeway, which is directly adjacent to the Palms Metro stop. Proposals must be received by October 9th, 2018. The project is expected to be completed by the end of March, 2019. The budget for this project is currently \$3,000. This budget is intended to cover artist's fee, travel, materials, documentation, and installation costs. Proposals with larger budgets may be considered pending availablity of additional community funding.

## **Project Description**

The project consists of a new mural installation which will run the entire length of the two concrete walls above the walkways under the 10 freeway overpass at Palms Ave., each of which is approximately 250 ft. long and 8 ft. high. The lower portion of the walls with the textured surface are not to be included in the project. The upper portion of the walls will be illuminated at night by pre-existing lighting. The Palms Neighborhood Council is overseeing the project in coordination with LA and California Dept.s of Transportation.

# Art Criteria & Goals

The goal of the project is to a) enhance a sense of community and of place within the community; b) celebrate unique aspects of the Palms neighborhood; and/or c) pay homage to the history of Palms. Because this location is both an entryway into the Palms neighborhood, and a highly trafficked area due to its proximity to both the 10 Freeway and the Metro Station, this project provides an opportunity to help define and reflect the Palms community.

## Artist Eligibility

Artists must live or work within the County of Los Angeles. Artists who have experience interacting with community and have completed similar projects are encouraged to apply. Equal opportunity statement...

# **Application Requirements**

A.Statement of interest describing why you or your team are submitting your proposal, your connection to the Palms neighborhood, your approach to the project, past relevant experience, and what you hope to communicate to the community through your proposed mural.

B. Resume or short biography of artist or artist team

C.Self-addressed stamped envelope (SASE) for the return of hardcopy materials if desired

D. Visual support materials, which can include digital images in pdf, jpeg, slideshow (PowerPoint or similar) or video formats, or prints. A maximum of ten images may be submitted. All images or videos should be file named or labeled so as to distinguish each image easily. Slideshows or videos should be no longer than 30 seconds in length.

## **Selection Process**

Applications will be reviewed by members of the Palms Neighborhood Council Commercial Corridor Committee members for eligibility and appropriateness on October 10th. All eligible submissions will then be forwarded to the full Palms Neighborhood Council for review and selection by way of voting on November 7th. Voting will initially be by runoff, where the top two vote-getters from the initial poll of members (three in case of a tie between the top two vote-getters) will then face each other for final voting and selection. Artists or artist teams are not required to travel to or attend the neighborhood council meetings where selections will take place, but these meetings are open to the public. **Selection Criteria** 

- A. Relevancy of the image(s) to the Palms neighborhood whether historically, culturally or otherwise.
- B. Appropriateness of image with regards to cultural and community diversity
- C. Visual interest and appeal
