The Palms Neighborhood Council takes exception to the requested CEQA exemption. There is substantial evidence that a full environmental review is required based on the gas station and the auto repair shop that are on the property and that the property is in a methane buffer zone. A gas station has existed at 10646 Venice Blvd at the corner of Overland, the west side of the project, for many decades. E&J Foreign Car Repair at 10602 Venice Blvd at the corner of Keystone, is on the east side of the project. We need strong assurances that the proper environmental procedures are being followed for the decommissioning and proper disposal of the gas station and the auto repair facility.

History shows that gas stations are responsible for considerable soil toxicity, especially older stations that have been in existence for considerable time.

The project requires additional study to sensitive receptors such as the Perez Family Child Care that shares an alley with this project at 3819 Keystone.

Our main interest is the health and safety of our current residents and any new residents we gain as a result of this project. Let us not cut corners where these priorities are concerned. The Palms Neighborhood Council urges a full environmental review

Matthew Hayden, a consultant for Wiseman Residential on this project, visited the Palms PLUM Committee on July 14, 2021. At that time we provided a list of 12 issues on which the Committee required further information and action before we would vote on the project. These issues are:


- Report back on plan for removing the gas station.
- Develop a plan, including barricades, to protect the children at the day care. The plan needs to be approved by the owner of the day care.
- Extermination before the demolition.
- Repave the full alley.
- Plan to secure the site.
- Setback on the Keystone side similar to the Overland side and on alley
- Protect existing trees and improve their quality of life by improving the tree wells. If Urban Forestry requires new trees, the new trees must be at the same level of maturity.
- Plan to move above grade parking below grade. At a minimum, we need a plan to see how it would be screened.
- Provide solar panels on the areas of the roof that are plain roofing.
- Park offsite during construction. Provide a plan.
- Report back on using art funds for a public art installation.
- Provide a landscape plan.

We also think this project requires a full environmental review and address that in a separate letter.

At this time, we have not seen progress on our list. While we haven't voted on the project, we are documenting our conditions for taking a vote and urge the Planning Department not to issue a letter of determination before the Palms NC is consulted on this list and has a reasonable opportunity to take a vote. At this point, our vote is not to support the project.



disagrees with the position, they can still bring it up, this is just to slow it down so that the tree doesn't quickly get removed. She has seen it happen where trees are removed within a week. It is better to err on the side of making the challenge and then dialing it back when you get the whole story from Urban Forestry. This position is not as critical as it used to be, because they have gotten Urban Forestry under a lot of pressure to really vet the tree removal requests to make sure they are on board with it. You can also confirm with the neighbors and/or call the property owners to talk to them about removing the trees.

- How do we determine when it is appropriate to remove a tree or not?
- Joanne says if we oppose one we will hear the opposite position from Urban Forestry. In general we need trees, and this isn't just her opinion. We are working towards getting people to not design driveways right where the trees are and Urban Forestry is giving people a hard time about it. She says sometimes you might not oppose the removal but you do oppose the replacement trees size, species, etc. Urban Forestry does make mistakes too. "They are only as good as the person they send out." She challenged a whole tree removal and replacement at the Board of Public Works because they were removing trees and replacing them with ornamental trees that are not shade trees and not native. There are times when you can look at a situation and there is no way around it or the tree is in bad shape, then you don't challenge it. It's mostly a stopgap and you can include more people, usually it's not decided very quickly. Joanne is happy to answer any questions.
- Joanne suggests sending the tree removal notice, also taking a picture of the tree, letting people know the tree and the situation, and whether we have decided to challenge it or not challenge it.
